Welcome to this unit of study

This unit describes the performance outcomes, skills and knowledge required to display merchandise in a retail environment. It requires the ability to prepare, produce and maintain merchandise displays in accordance with visual merchandising requirements.

This unit applies to all retail sectors and business sizes from large format stores to small independents. It applies to frontline personnel who have limited autonomy and work under close supervision and guidance of others in frontline operational roles in the retail environment. However in smaller retail businesses, senior personnel might also undertake this function.

It may be undertaken as:

- » part of a formal qualification nationally recognised through the Australian Qualifications Framework (AQF)
- » a stand alone unit
- » part of a formal skill set
