

- Catapult Smallprint Pty Ltd ABN 11 649 627 154 (Catapult Smallprint, our, us or we) publishes online learning and training materials, divided into individual subject modules (Units).
- Catapult Smallprint offers access to those Units for a fee that is payable for each student enrolled in a given Unit (Enrolment Fee).
- These terms and conditions are made available to you before you are granted access to any of the Units. By proceeding to access any of the Units, you agree to be bound by these terms and conditions. If you disagree with any of these terms and conditions, do **not** access the Units.
- 4. You acknowledge that:
- Catapult Smallprint or its associated entities own all copyright, inventions, (a) patents, trademarks, circuit layouts and all other rights in the Units arising from intellectual activity in the industrial, scientific, literary or artistic fields (Intellectual Property Rights). You will not engage in any acts which challenge, oppose or infringe those Intellectual Property Rights; and
- individuals that are officers or employees of Catapult Smallprint or its associated entities own all moral rights in the works comprised within the Units, within the meaning of the Copyright Act 1968 (Cth) (Moral Rights). You will not engage in any acts which infringe those Moral Rights.
- In consideration of your compliance with these terms and conditions and payment of the Enrolment Fee, Catapult Smallprint grants to you a limited and revocable right to use the Units to deliver the training course to your enrolled students. This right cannot be transferred or sub-licensed without our prior written consent. If your training organisation or enrolled students fail to pay the Enrolment Fee, we reserve the right to suspend and/or terminate your access to the Units.
- Subject to any suspension or termination of your access under clause 5, you may view the contents of the Units for which you have paid the Enrolment Fee:
- for the purposes of reviewing, creating, editing and deleting student and (a) trainer submissions:
- printing and downloading limited content, where expressly permitted by (b) Catapult Smallprint;
- for the purposes of administering the training course of which you are the administrator or trainer.
- The Units (including any of their content) must not be shared in peer to peer networks, broadcasted (whether on social media or any website) or communicated to the public without our prior written consent and such actions will be regarded as Intellectual Property Rights infringement.
- You will not, without Catapult Smallprint's prior written consent, reproduce the Units, remove trademarks, corporate names, branding or other insignia from the Units, distribute the Units or make them available to any person except trainers who are also providing training for that Unit, or students who are enrolled in that Unit.
- You must ensure that all users to whom you grant access to the Units are made aware of your obligations under these terms and conditions, and agree to refrain from any acts or omissions which might cause you to breach your obligations under these terms and conditions. You agree to indemnify us against any direct losses that we may suffer, arising from or in connection with unauthorised use of the Units by persons to whom you have granted access.
- The Units are designed for use as a learning tool, and no representations are made by Catapult Smallprint as to their fitness for any other purpose.



- As a user of Catapult Smallprint's products (including its Units), services and any of its learning management systems (LMS) (collectively the Services), you will not:
- reverse engineer, decompile or attempt to extract the source code of the LMS (a) or any other software to which you have been granted access by Catapult Smallprint;
- engage in illegal or unlawful activities, or any other acts that facilitate criminal activity;
- install spiders, data scrapers, viruses or other malicious software which may (c) threaten the integrity and security of the LMS, our website or other Services;

- use our Services to infringe a third party's Intellectual Property Rights, (i) confidential information or other legal rights.
- You must not access, tamper with, or use any restricted areas of the Services to which we have not granted you access. Our Services and the systems of third party providers that assist us in delivering the Services must not be:
- (a) probed, scanned, or vulnerability tested;
- the subject of circumvention of any security or authentication measures; (b)

- 12. You will not use encryption technology or other technological measures to interfere with our Services or to otherwise infringe our Intellectual Property Rights. You will provide reasonable cooperation to assist us with identifying the source of any problem with the Services that we reasonably suspect may be attributable to your network or third party providers that you use in conjunction with our Services.
- 13. You acknowledge and agree that:
- there are inherent risks in dealings over the internet. Catapult Smallprint does (a) not warrant that files, information, programs, Units or data, information or other materials you submit (User Content) available from or via any of our Services accessible via the internet, are free from harmful code; and
